For example, due to a lengthy process of obtaining planning permission, it took fourteen years before all four construction phases of the commercial park "West Erding Park" near Munich could be approved and completed. The project has a floor surface area of 61,000 square metres.

Our success story began with the acquisition and management of residential and commercial real estate as well as manufacturing sites. To this day, asset management remains one of RH Unternehmensgruppe's important business segments.

Many of the properties we have developed in Germany and Austria remain in our portfolio for years and even decades, including the original main location of Feinkost Käfer (Käfer's Fine Foods) on Prinzregentenstrasse in Munich, the "Hotel Zoo Berlin" on Kurfürstendamm in Berlin, or the "West Erding Park" commercial park in Erding near Munich.



RH Unternehmensgruppe has been firmly established in the German real estate landscape for more than sixty-five years and three generations. The cornerstone of this success story was laid by Käthe Stelzer, Robert Hübner's grandmother, when she purchased a building at Prinzregentenstrasse 73 in Munich-Bogenhausen in 1956. At the time, the building housed a grocery store called Feinkost Käfer (Käfer's Fine Foods), which today is Munich's most famous gourmet temple and known far beyond the borders of the Bavarian capital. The magnificent pre-war building from 1902 has been renovated and enlarged several times over the years. It remains in our portfolio to this day and has very special significance for us as the owning family.

In 1995, Robert Hübner took over management of all family-owned businesses and is now the third generation to lead the company. We fondly look back at the milestones in the development of our business and look forward to further innovative and stable-value construction projects, which are ready for launch. At the same time, we acknowledge the responsibility of an orderly succession to the fourth generation of the Hübner family. We are proud and confident that we will be able to continue making our contribution to visionary and sustainable urban development in Germany and Austria, and in doing so, to help shape living and working of tomorrow.

The building includes 150 rooms and suites, a restaurant, a bar, a conference area, and spa with rooftop pool. The entrance, bar, and restaurant were redesigned with quiet elegance in mind. The proportions of the open lobby with reception and piano bar are generous. The refurbishing was done with high-end materials in warm earthy tones and carefully coordinated accessories. The space concept and modern interpretation of an alpine interior lend the hotel a convivial and inviting atmosphere.



After just 14 months of construction, the ibis Hotel opened just in time for Oktoberfest 2009. At the time, with 208 rooms, it was the largest hotel of the Accor Economy brand in Munich and one of the most modern in Europe sporting the new corporate design. Eyecatcher and central meeting point is the newly designed, spacious open lobby, which was first realised in Munich. It is comprised of a reception area, a business corner, a bar, and an innovative restaurant with an open-view kitchen and a sunny terrace. The special challenge of this new building project was in laying the foundation above an operating subway train shaft: The task was to decouple the building from the vibrations caused by the trains below.

The new four-star hotel in Berlin's Prenzlauer Allee opened its doors in 1993. In 2019, after more than twenty-five years in business, the owners, RH Unternehmensgruppe and Manfred Weingärtner, renovated the property from top to bottom in only fourteen weeks. The 123 rooms, corridors, stairwells, and common areas, and the exterior façade were revitalised and the building's service installations modernised. Highlights are the open lobby with reception area, the bar and lounge with a refined look and innovative design, the newly conceived foyer with an exterior entryway as well as the completely revised mullion-transom façade in the lobby area.

Go Four It

In Munich, a business quarter will be created whose innovative and integrative architecture will be clearly visible and make a distinct mark on the entire neighbourhood. The four buildings will feature staggered floors between the fourth and sixth stories. Each will be individually designed according to their planned use, but also partially connected to each other using unusual horizontal and vertical elements. The rooftops will be integrated into the overall concept and offer space for gardens, quiet zones, and terraces. A communal, car-free avenue over 200 metres in length and up to 18 metres wide, will connect the buildings to form a lively campus of networked space for workplaces adapted to many different sectors and areas. This will all enable dynamic transitioning between work, recreation, and relaxation.

M Square

The "M Square" office complex in Munich's Westend district combines the best of trailblazing architecture with resource-saving construction. The impressive new building at house numbers 65 to 67 was completed in 2001. The existing building was renovated a decade or so later and the underground parking garage modernised, all while remaining fully rented. The new building and the renovated structure blend harmoniously to create an exciting ensemble with expansive, streamlined glass fronts and spacious interior design. The building structure was conceived according to modern standards for multi-tenant usage. Sustainability and energy efficiency when carrying out the construction work was a top priority. As a result, the building received the prestigious Gold LEED Green Building Certificate in 2016.

Zielstatt Quartier

Project development of the "Zielstatt Quartier" office park was carried out in several construction phases. The first phase involved the complete renovation of the existing building at number 32, which housed manufacturing space. This was followed by construction of several new office buildings, whose spaces were individually completed according to specific tenant requirements. The Bauhaus-inspired office park has a narrow front with large window areas. The entire neighbourhood is marked by the architecture and features of the campus, with its studios and stylish offices with access to rooftop terraces, communal areas, carefully designed landscaping, and sustainable construction methods.

The magnificent building at Prinzregentenstrasse 73 has been in the Hübner family since 1956. The property, where one finds Feinkost Käfer, a top address in Munich and home to a fine food shop, restaurant, and wine cellar. Built in 1902 and completely renovated in 2014, the building has a decorative front with oriels, gables, and various embellishments, a host of salons, and a spacious shop.

Gewerbehof Dachau

The "Gewerbehof Dachau" has been owned by the Hübner family for more than forty years. RH Unternehmensgruppe took over sole ownership in autumn 2016. Since 2019, it has been undergoing gradual renovation and extensive modernisation. Some sections of the building were completely re-designed. In doing so, around a fifth of the space on the western side was re-designated as residential space. The old structure was gutted and eleven rental apartments were created on three floors plus seven garages, all within fourteen months. Some 4,100 square metres of rentable space are still available for commercial use. The parking deck, built from scratch in 2019, offers twenty-seven spaces on two levels.
